## 2021 ALBARINO YAKIMA VALLEY - CRAWFORD VINEYARD

Albarino is a white wine variety indigenous to the Iberian Peninsula and recently planted in eastern Washington. The **2021 ALBARINO** is our ninth vintage for this variety and was sourced from the Crawford Vineyard near Prosser in the Yakima Valley. Hand harvested in early October at 24.2 Brix, the fruit was crushed and pressed immediately and allowed to settle overnight. The juice was racked off lees and cool fermented in stainless steel for five weeks. After cold stabilization and without fining, the wine was filtered and bottled in January 2022. The resulting wine has the classical aromas of Albarino including pineapple, mango, apricot and especially pear with a light gold color. Alcohol 13%, residual sugar 3 g/L, pH 3.55 and titratable acidity of 6.3 g/L. Only 205 cases produced and released February 2022. Sold only in Washington State at the tasting room and select retail outlets. Suggested retail: \$22/bottle.

Harvested in early October, it was cool fermented to maximize the intense pear and apricot aromas characteristic of this variety. Only 200 cases produced.
